**THE FERTILISERS AND CHEMICALS TRAVANCORE LTD**., a multi-divisional Central PSE, and pioneer in the manufacture and marketing of Fertilisers, Chemicals and Caprolactam, with activities spread over Manufacturing, Engineering Design and Consultancy, Fabrication etc., invites applications from eligible candidates for engagement on **Fixed Tenure Contract (Adhoc basis)** to the following post:

# 1. Relevant date to determine eligibility on qualification, experience, age etc is 01.xx.2023.

2. Candidates shall submit along with application, experience certificate to establish the relevant prescribed experience, if any, claimed in their application, failing which such experience (s) will not be considered. Candidates who are presently working in any establishment, in the absence of experience certificate from that establishment, should submit reasonable proof of work experience to the satisfaction of Management, which includes copy of Appointment / Offer letter issued by the establishment, date of joining, latest pay slip etc, without which such experience will not be counted.

### General terms and conditions for appointment

1. The engagement will be for a term of two years, renewable for a maximum period of 2 spells of one year each, at the discretion of the Management, subject to requirement, performance, assessment etc. Engagement is also liable to be terminated by the Management with 15 days' notice or pay in lieu of notice, at its discretion without assigning any reason.



- 2. **Emoluments:** Candidates offered engagement as above with relevant experience of one year will be paid a consolidated pay of Rs.43,000/- per month and an increase of Rs.2,000/-for each additional year of relevant experience over 1 year, subject to a maximum consolidated pay of Rs.65,000/- per month. On successful completion of each year / renewal of contract, if any, an increase of 3% on consolidated pay will be paid. Leave, Accident Insurance Coverage, Provident Fund, TA & DA for duty travel, Rent Free accommodation but with applicable Service Charges etc, will be applicable based on eligibility, as per Rules of the Company.
- 3. Age: Maximum age shall be 35 years. Eligible candidates should have been born on or between 01.11.1988 and 30.10.2005. Relaxation in maximum age limit is permissible for reserved posts as per government directives. Age will be further relaxable to the extent of one year for each additional completed year of relevant experience over 1 year. Maximum age after all relaxation shall be 58 years. Matriculation / School Leaving Certificate granted by Board of Secondary Education shall be the only acceptable document in support of proof of age.
- 4. Reservation will be applicable as per Government Directives. EWS candidates shall submit EWS certificate of relevant year (income of FY 2022-23). OBC-NCL Candidates shall submit self-declaration along with the application, in the prescribed format provided in the website and if engaged shall produce OBC-NCL certificate issued by competent authority within 6 months prior to joining.
- 5. Only full time regular courses will be considered for the prescribed educational qualification specified under the specifications. Qualification acquired through part time /correspondence/distance/ private study/off campus will not be considered.
- 6. Educational Qualifications shall be approved / recognized by Medical Council of India.
- 7. Candidates will be required to undergo pre-employment medical examination and those certified fit by the Company's Medical Officer will only be offered appointment. The engagement will be subject to the candidate being fit and continuing to be fit as per the standards prescribed by the Company. No relaxation in Medical/Physical standards will be allowed. The opinion of the Company Medical Officer in this regard shall be final.
- 8. Engagement under this notification is only for fixed term and will not in any way directly or indirectly confer any right for extension of term of engagement or for permanent appointment or preferential treatment in appointment in the Company.
- 9. Selection shall be based on interview. Management reserves the right to (i) short list candidates by adopting methods or criteria found suitable at the discretion of the Management and (ii) modify the mode of selection etc. The decision of the Management about the mode of selection, requirements, eligibility criteria, shortlisting of candidates etc. shall be final and binding. No correspondence will be entertained in this regard.
- 10. Only Indian nationals are eligible to apply.
- 11. Meeting the eligibility criteria / attending or being successful in the interview by itself will not confer any right on the applicant for selection or to be included in the



Panel or for engagement.

- 12. Eligibility of candidates will be determined based on information furnished in application and documents submitted by the candidates. In all stages of the selection process, candidature will be provisional.
- 13. Engagement from the panel will be at the discretion of Management, subject to requirements, and reservation rules.
- 14. Interested candidates from the panel may be considered for engagement for periods of shorter duration too, based on requirements of the Company at rates/ terms fixed by the Company for such engagement.
- 15. - 18. Incomplete applications, applications without signature and photograph, and/or without documents in proof of eligibility are liable to be rejected. Originals of the documents shall be furnished as and when called for.
